SUMMARY

The Online High School Mentor helps improve student achievement by identifying the needs of its students, encouraging them to complete assignments, communicating with their teacher, and accessing services that the Utah Online High School provides, such as technical support and tutoring services.

ESSENTIAL DUTIES AND RESPONSIBILITIES *may include the following. Regular attendance and timeliness is an essential job function to perform the essential duties and responsibilities of the position. While this job description attempts to outline all essential duties of the position, the description is not a contract and the job functions are subject to change at the organization's discretion. Other duties may be assigned.*

Meets weekly at a pre-determined time, to discuss the needs of the mentored students.

Collaborates with Online School director, coordinator, staff members and school secretaries to facilitate their project roles and responsibilities.

Contacts each student (and/or their parent) at least weekly by email, or phone.

Consults with parents when necessary regarding their children and plans strategies that will assist the student and parents in following the semester schedule, and taking their exams on time.

Helps connect students to tutoring or other services provided by the school in order for the student to complete the required assignments and tests.

Assists with student programs and educational plans to meet educational goals and objectives.

Assists in the execution of timeline and progress toward meeting project goals and objectives.

Assists with program evaluation activities.

Additional travel may be required.

Completes other duties and activities as assigned by the coordinator or other supervisors.

Maintains regular attendance and punctuality which are critical in order to complete the day to day tasks of this position.

Ability to apply common sense understanding to carry out essential duties of this position. Ability to carry out instructions furnished in written, oral, or diagram form. Ability to troubleshoot and solve problems involving concrete variables situations. Ability to define problems, collect data, establish facts, and draw valid conclusions.

High school diploma or general education degree (GED); or six months to one year related experience and/or training; or equivalent combination of education and experience.

This position does not require any certificates or licenses.
